

# **Lumina's Commitment to Educational Quality**

### To Achieve Quality, We Must Focus Our Efforts

The country's structures for assuring the quality of college degrees and other credentials awarded after high school no longer meet the needs of today's students, society, or the economy. Policies and practices must be updated to ensure that the learning represented by all degrees, certificates, industry certifications, and other credentials will indeed help people lead fulfilling lives and obtain and succeed in better jobs, while also building a stronger American society and economy.

An updated system of assuring quality in learning beyond high school is particularly important given the stark disparities that exist across racial, ethnic, and income groups — disparities that prevent Black, Hispanic, and Native American people from advancing socially and economically, in part because they lack quality credentials beyond a high school diploma. Troubling inequities exist in gaining access to many quality learning experiences. The country must do much more to remove obstacles that people of color and people from low-income families face in charting their course to successful graduation. Too many of these students see too few options to pursue high-quality credentials and may be drawn to low-quality, high-priced programs that offer convenience but lead nowhere.

At Lumina Foundation, we are convinced of the need for a better approach — one that prioritizes students, assures the quality of learning, and produces fair and just results for people of color. Every academic or training program should clearly state what people will know and be able to do when they're finished, and this learning should be validly and reliably assessed in context. Programs should have relevance in the job market and equip people to pursue additional learning over the course of their lives while helping them succeed in a rapidly changing world of work and flourish in their lives as leaders and participants in a diverse democracy.

- Prioritize eliminating disparities in educational outcomes among Black, Hispanic, and Native American populations.
- Address structures and beliefs that divert vulnerable populations into lower-quality programs.

- Promote new forms of quality assurance that enable responsible innovation.
- Ensure that data systems can identify internal barriers and foster racial equity.
- Encourage adequate public funding to serve those students who require the most support.

### To Achieve Equity, We Must Focus Our Efforts

The promise of American opportunity has always been in sharp contrast with our nation's legacy of racial discrimination and oppression. At Lumina Foundation, we pursue racial equity and its foundation of diversity and inclusion to combat systemic patterns of racism that foster injustice.

A lack of access to high-quality learning opportunities after high school with adequate academic, financial, and social supports has denied Black, Hispanic, and Native American people opportunities to advance economically and to fully participate in society. Racial disparities in the United States are widening, and without concerted efforts, inequity will only continue to grow.

Intentionally designed policies and deliberate actions created these unjust conditions. It will take equally focused efforts to achieve racial equity in America.

At Lumina, we believe achieving fair and just outcomes for people of color must be the mission of higher education.

Amid its challenges, education and training after high school remains one of the most secure, sustainable pathways to economic stability. But we need a learning system that works well for everyone, especially for communities of color who disproportionately experience inequality.

Unfortunately, today's education systems fail to meet the needs of many of today's students. These students are more racially and ethnically diverse. They are more likely to work full time. And they are more likely to experience homelessness, poverty, and food insecurity.

These circumstances reflect widening gaps in income, wealth, and access to opportunity that create barriers to economic and social mobility.

- Promote the capacity of our contractors and grantees to pursue racial equity, diversity, and inclusion.
- Foster and support efforts to promote racial equity, diversity, and inclusion within philanthropy.
